Work Force Changes:.

WorkShare

Maine Department of Labor officials are launching a newunemployment initiative this month aimed at keeping workers on the job when their employer experiences a temporary slowdown in business.

To be eligible for WorkShare, the employer needs to demonstrate that a layoff would have impacted at least 10% of workers for a two- to six-month period. The reduction in hours must be at least 10%, but not more than 50%, and work can't be seasonal or temporary. Workers looking to receive partial unemployment benefits must be included in the affected unit of the business; have earned enough wages to meet the regular qualifications for unemployment benefits; and be able to work their normally scheduled hours. Partial unemployment benefits are paid in a percentage equal to the reduction in hours.

Applications for Workshare must be filed by the employer. Employers should call (207) 621-5116 for more information.

Youth Employment

For teens under the age of 16, restrictions limit the types of jobs and the hours they can work. Minors cannot work jobs considered "hazardous." The Department of Labor's Bureau of Labor Standards has updated the restrictions to bring them more in line with current federal requirements. This change will now allow minors under the age of 16 in Maine to work in movie theaters and bowling alleys and to do more jobs than were permitted previously in such establishments as hotels, motels, and bakeries. For example, although 15-year-olds may not operate the ovens, they can decorate cakes, fill pastries, stock the display cases, and serve customers.

Some of the jobs Maine teens under 18 years old cannot do include operating most mechanical equipment, driving for work, and working alone in a cash-based business.

The revisions have been made to help both employers and teens. "Summer jobs create an opportunity to connect students with pride in earning a paycheck and helping others," said Maine Department of Labor Commissioner Robert Winglass. "Young people can develop a strong work ethic and learn how to manage money."

There a fewsteps teens must go through to obtain a work permit. First, teens must look for work and receive a job offer. They then must apply for a work permit at the office of the superintendent of the school district in which they live. All minors under the age of 16 must have a work permit before they start a job, whether or not they attend school. The school district sends the completed application to the Maine Department of Labor for approval. Teens can have two work permits (for two different jobs) in the summer, but only one permit during the school year.

Parents and employers can help expedite the approval process by making sure the work permit request includes both proof of age and parental/guardian approval. The application must contain the specific job title (e.g. "dishwasher"). The name of the business on the permit must be the actual business name, which may be different than what people commonly call it. The Bureau of Labor Standards has sent the updated list of restricted employment to all school districts in Maine.

A copy of the Guide to Maine Laws Governing the Employment of Minors is posted on the Maine Department of Labor website and is available by request by calling 623-7900.

Employers can upload and manage job postings on Maine's Job Bank at no cost, and workers can search for jobs that match their qualifications and preferences. Thousands of Maine jobs are posted on Maine's Job Bank, and the service attracts visits from thousands of job seekers each week.



Maine Regulatory Fairness Board

Fact Sheet



What is the Regulatory Fairness Board?

The Maine Regulatory Fairness Board (RFB) invites public testimony on regulatory and statutory issues that impact Maine businesses. To effectively report to the Legislature and the Governor on regulatory conflicts, the Board elicits public comment from Maine business owners/managers and the public concerning:

- specific state rules and regulations that may unreasonably impede business sustainability and growth; and
- recommendations for regulatory and statutory change that may enhance Maine's business climate.

The Board holds hearings in various parts of the state to invite testimony that highlights and details regulations in need of scrutiny and amendment. The Board announces these hearings via news releases and websites* to attract those who wish to present their perspectives on pertinent topics. The Board also holds public meetings in Augusta where it weighs public comments and addresses administrative matters to advance operational goals and objectives.

These public comments directly set the hearing agendas and greatly inform the Board's recommendations to the Governor and the Legislature. Public participation is thus an essential element to achieving the Board's goals and objectives. Please consider attending meetings whenever possible to share your valuable insights.

Who serves on the Regulatory Fairness Board?

The Board is chaired by the Secretary of State and is comprised of four members who are or have been owners or operators of Maine businesses. It is staffed by Maine's Small Business Advocate. One member is appointed by the President of the Senate, one member is appointed by the Speaker of the House, and two members are appointed by the Governor, one of whom represents businesses with fewer than 50 employees and another who represents those with fewer than 20 employees.

Private sector members of the Board volunteer their time and their unique expertise to serve as liaisons between the State's business community, regulatory authorities, and lawmakers. Board members serve three-year terms and may serve up to three consecutive terms.

Small Business Advocate Jay Martin

What is the Small Business Advocate's role?

Maine's Small Business Advocate serves as an independent voice for Maine small business owners within our state's regulatory system. The Advocate works directly with small businesses (50 employees or fewer) that have specific grievances with one or more regulatory agency's enforcement actions. The Advocate's top priority is to assist small business owners who feel they are being treated unfairly or improperly by state agencies.

The Advocate is not a substitute for established agency procedures or the formal appeals process. The Advocate cannot provide legal advice or reverse legal or adjudicatory determinations.

Why is the work of the Small Business Advocate important?

As an appointee of Maine's Secretary of State, the Advocate serves as an independent, accountable and appropriate check on the state's efforts to regulate Maine businesses. This role is the first of its kind in the state and the nation, demonstrating our state's commitment to ensuring Maine's small businesses have every chance at success.

The Advocate advises and staffs the Regulatory Fairness Board, chaired by the Secretary of State. This board, with members from the private sector appointed by the Governor, President of the Senate, and Speaker of the House, reports to the legislature and Governor annually with recommendations for regulatory and statutory changes that may enhance Maine's business climate. The Advocate comments on proposed rules and testifies on legislation affecting the interests of Maine's small businesses. Please contact the Advocate to share your ideas on improving Maine's regulatory environment.

How are small businesses served by the Small Business Advocate?

- 1. A small business owner who feels he or she is being treated unfairly or inappropriately by a state agency in a way that may create an economic hardship can request assistance from the Small Business Advocate. Business owners seeking assistance should be prepared to offer complete and accurate information to enable the Advocate to effectively research and address their concerns.
- The Advocate researches pertinent statutes and rules/regulations, and consults with the small business and state agency/ies involved to determine the facts underlying the complaint.
- The Advocate serves as an intermediary between the small business and the agency/ies to determine an appropriate course to address legitimate grievances.
- 4. When necessary, the Advocate will request that the Secretary of State issue a regulatory impact notice to the Governor outlining the fact finding and recommending an alternative means of effective enforcement that would relieve the small business of the significant economic hardship imposed.
